2. Scouts camp

(20%)

The scout organization is organizing a big summer camp every year. Based on the complaints from previous years, they want to ensure that girls do not face so long queues in front of their toilets. At the peak hours, boys have to wait on average 1,5 minute. At the peak hours, the arrival rate of girls to the toilets is on average 50 per hour (Poisson distribution is an appropriate approximation). On average, a girl needs 2 minutes between entering and exiting a toilet room. There is a separate line for each toilet room. How many toilet rooms are needed so that the expected waiting time before the girls' toilets is not more than $\frac{2}{3}$ longer than for boys?

3. Safety stock

(20%)

The company is facing a variable daily demand with a mean of 20 and standard deviation of 10. The inventory is ordered once every 15 days, and the delivery time is 1 day. The management wants to avoid stock-outs in 96% of time. The holding cost is 100€ per unit per month.

a) What is the total yearly holding cost of safety stock?

b) What is the average ordering quantity?

c) Why is the ordering quantity not constant?

4. Frozen chickens (10%)

A grocery shop has currently on stock 2000 frozen chickens with average weight 1500 g and standard deviation 250 g. For chickens with weight above 2000 g or below 1250 g, they offer a discount price.

How many chickens are expected to have a regular price?

5. The Goal, question 1 (15%)

Comment and explain the situation in the plant from the beginning of the book: “...*this plant has four ranks of priority for orders: Hot, Very hot, Red hot, and Do It Now.*” What was the situation in regards to shipping orders after changed management of the operations?

What does it mean “*being concerned with local optimums*” when managing operations of a plant? What are the consequence of such approach? Describe this in the context from the book.
